




# HP 32305A

HP General Ledger is a customizable accounting application for the HP3000 which automates the collection, organization and summarization of financial information. The capabilities of HP General Ledger may be expanded to include a second ledger and allocation features with the purchase of HP Dual Ledger and HP Allocator.

### Features

- \* On line or batch data entry, validation, up-date and review.
- \* Supports multiple companies with unique charts of accounts, cost center organizations, security, fiscal years, and default values.
- \* Up to 13 accounting periods are kept for both last year's and current year's data.
- \* Total flexibility is available in defining charts of accounts and cost centers.
- \* Three budget amounts are kept at account, cost center, or account within cost center levels.
- \* On-line analysis of expenses and budgets.
- \* Accruals provide automatic reversal bookings.
- \* Standard vouchers automatically posted.
- \* Ability to post to future or past periods.
- \* Automated period and year-end closing procedures.
- \* On-line "Help" screens for quick reference.

### **Customization Capabilities**

- \* Customization of accounting parameters is done through interactive definition screens and stored in external files. \* Fields can be added to or deleted from the data bases and the characteristics of existing items can be changed.
- \* Menu and transaction screens can be added, deleted, or resequenced.
- \* Fields can be added, changed, rearranged or deleted on existing screens.
- \* System values can be modified.
- \* Help screens and error messages can be modified.
- \* Passwords can be associated with companies, functions or terminals.
- \* Reports can be modified and new reports can be defined using HP Report Facility.
- \* Interfaces can be modified and new interfaces can be defined using HP Interface Facility.

## System Environment

For HP General Ledger, the minimum system recommended is any HP3000 Series with 1Mb of memory. The amount of memory, disc space and type of backup device needed will depend upon each configuration and expectations regarding transaction volume and terminal response time. HP terminals must be block mode, VPLUS/3000 compatible and have screen labeled function keys.

HP General Ledger requires the HP3000 Fundamental Operating Software including MPE IV, VPLUS/3000, KSAM/3000 and IMAGE/3000.
