Introduction

The PORTABLE from Hewlett-Packard has combined the power and capabilities of a state-of-the-art desktop personal computer with the portability of a notebook.

Software and hardware combine to provide an unparalleled solution for mobile professionals such as consultants, sales and service professionals, accountants, and journalists. Lotus 1-2-3 (TM), Memomaker, and terminal emulation are all built permanently into ROM for lightening fast performance and ease of use.

Complete online "help" is always available for all built-in applications. Pulling it all together is the Personal Applications Manager (PAM), which provides access to the facilities of the MS-DOS (TM) operating system without having to learn a whole set of commands.

The PORTABLE is also compatible. It runs desktop software with the same user interface, the same speed of execution, and the same memory complement as most desktop personal computers. It is 100% data compatible with the HP 150-II and IBM PC. The PORTABLE DESKTOP link makes transfering files from the Portable to an IBM PC quick and easy.

A Total System

The PORTABLE is a powerful, stand-alone personal computer. However, battery powered portable/desktop peripherals can be added to enhance the system.

The HP 9114A PORTABLE MicroFloppy drive weighs only 5.5 pounds but can store 710k bytes of information. Like The PORTABLE, it is battery operated.

Need portable printing? The Thinkjet personal printer is the answer. 150 characters per second ink jet printing on battery power.

The entire system, The PORTABLE, HP 9114A, and Thinkjet weigh less than 20 pounds and fit in a system case that is easily carried.

Product Positioning

Until now, there has been a tradeoff between functionality and portability. Either you get the functionality of a desktop (with commensurate weight and bulk) or the portability of a notebook (with a loss of functionality).

The marketplace is defining a power threshold, that level of functionality required to be a personal computer. That includes a graphics display, quarter megabyte of memory, 16 bit processor, and business productivity software such as 1-2-3. The PORTABLE meets all these criteria.

A standard for portability is also emerging. To be portable, a computer must weigh less than 10 pounds, be battery operable for a long period of time (at least a working day), and fit in a briefcase. With battery power must come the confidence of using it away from an AC outlet. The PORTABLE meets these criteria as well.

The PORTABLE is in a unique position of satisfying the power threshold without sacrificing portability.

The Market

1985 may well be remembered as the year of the portable. It marks the merging of technology and market demand. Only about one-third of personal computer users expect to use their computer only at their desk and about half expect to take it home with them at night or on weekends.

The U.S. professional labor force (19.2 million people) can be segmented along mobility lines.

Questions and Answers

- Q. Can I use the PORTABLE on airplanes?
- A. The FAA has left it to the individual carrier to determine what electronic products can be used aboard commercial aircraft. Extensive testing of The PORTABLE show no interference with aircraft instrumentation. United Airlines, American, Eastern, and TWA allow The PROTABLE to be used aboard their planes. Many other carriers have allowed its use, but have no official policy statement. It's best to check with the cabin crew if there is any doubt.
- Q. Can I run IBM PC software?
- A. Although data files are 100% compatible between like programs on the IBM PC and The PORTABLE, small differences in the architecture of the two products make the software programs themselves incompatible.
- Q. Why doesn't The PORTABLE have a built-in disc drive?
- A. It does. Two electronic discs are built in. One has nearly \$1000 of popular software permanently installed and the other is for data and other software programs. A floppy disc was not built into The PORTABLE because of size, weight, and power considerations.

And, for those times that a portable disc is really needed, the HP 9114A fits to a tee. By packaging the disc and printer separately, performance and battery life of all three could be optimized without compromising portability.
